The WAREHOUSE, recently constructed by John Stockton of the Utah Jazz, is located across the street from Gonzaga University. The facility, opened November 1, 2002, houses five full sized state of the art gymnasiums. The facilities include all hardwood flooring, glass backboards, and top of the line scoreboards and shot clocks. The WAREHOUSE also includes six volleyball courts and a premium indoor baseball facility.
