**POOL PLAY:** THERE WILL BE TWO POOLS OF FOUR IN EACH GRADE. THE TOP TWO TEAMS IN EACH POOL WILL ADVANCE TO THE SEMIFINALS. THE WINNERS IN THE SEMI'S WILL PLAY A FIFTH GAME. THE THIRD AND FOURTH PLACE FINISHERS IN EACH POOL WILL PLAY A FOURTH GAME WITH A TEAM FROM THE OPPOSITE POOL. IN CASE OF TIES, HEAD TO HEAD AND POINT DIFFERENTIAL WILL BE USED (20 POINT MAXIMUM).

## **BRYAN DUNN MEMORIAL GAME RULES**

**Home team is listed on the left in the tournament schedules. Wears white jersey if there is a color conflict.**

**No full court press with a 20 point lead.**

**7 minute quarters. One minute between quarters. 3 minutes between halves.**

**2 time outs per half with no carry overs. One minute for time outs.**

**Overtime is 3 minutes. Start with a jump ball. One time out for each team only.**

**Next overtime is sudden death. First to score a point wins. Start with a jump ball. No timeouts.**

**For championship games, all overtimes are 3 minutes with one time out for each team. No sudden death.**

**Two technicals by a coach or two technicals by a player results in ejection from the game and the gym. Failure to leave the gym will result in the team forfeiting the game.**

**If a referee considers a parent or fan verbally abusive, the referee will warn the coach to control that person. If the abuse continues, a technical foul will be charged to the team, and the parent or fan must leave the gym. Failure to do so will result in the team forfeiting the game.**

**Any technical, flagrant, or intentional foul is an automatic 2 points and possession of the ball for the opposing team.**

**Only one coach per team will be allowed to stand in front of the team bench.**

**The gym monitor has the authority to remove any spectator that is causing any disruptions in the gym.**

**Each team will provide a scorekeeper. They are responsible to check each other for accuracy. The home team scorekeeper will have the official scoresheet. The referee will have the final decision on any dispute.**
