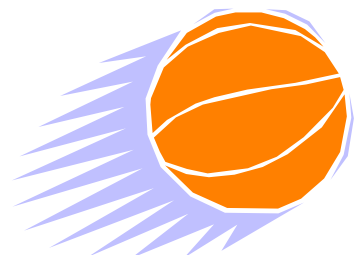
RULES OF PLAY: 2000-20001 High School Rules will be played.
